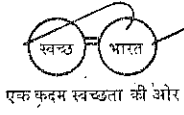

ORDER

Subject: Appeal made by Shri Sourabh Bhokare, Maharashtra under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Sourabh Bhokare, Maharashtra vide application dated 12.05.2024, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 14.04.2024.

Vide RTI application dated 14.04.2024, Shri Sourabh Bhokare had sought the information regarding consultation from Dr. S. C. Shukla, Assistant Director (Tech), EIA-Chennai to get the EIC Accreditation.

CPIO, EIC vide reply dated 30.04.2024 had informed that the information sought in the RTI application is not relevant and not applicable.


In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 12.05.2024.

The appellant in his appeal has stated that the CPIO has provided incomplete, misleading or false information.

Orders:

The appellate authority has find no infirmity in the reply of CPIO, EIC, therefore disposes off the appeal without any further directions to CPIO, EIC. This disposes off the appeal of Shri Sourabh Bhokare.
