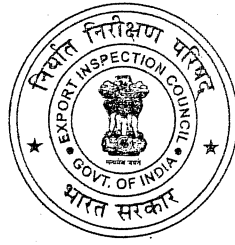
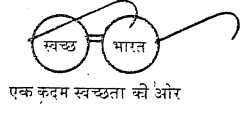

### ORDER

**Subject: Appeal made by Shri Venkatarama R, Chennai under Section 19(1) of the Right to Information Act, 2005 – reg.**

#### **Facts of the Case:**

Shri Venkataram R, Chennai vide application dated 07.06.2024, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 09.05.2024.

Vide RTI application dated 09.05.2024, Shri Venkatarama R had sought the information regarding copies of the Agenda and Minutes of the 84, 86, 87, 88, 97 Council Meeting of EIC.

CPIO, EIC vide reply dated 07.06.2024 had informed that the said Agenda and Minutes are not placed in public domain and does not involve any larger public interest, hence the sought information cannot be shared as per Section 8(1)(j) of RTI Act, 2005

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 07.06.2024.

The appellant in his appeal has stated that the CPIO has refused access to information requested and asked to advice the CPIO to provide the details.

#### **Orders:**

The appellate authority has find no infirmity in the reply of CPIO, EIC, therefore disposes off the appeal without any further directions to CPIO, EIC. This disposes off the appeal of Shri Venkatarama R.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
